The chances of winning a lemon law case depend on the facts of the case. However, if you have a strong case, you have a good chance of winning. The following factors can increase your chances of winning:

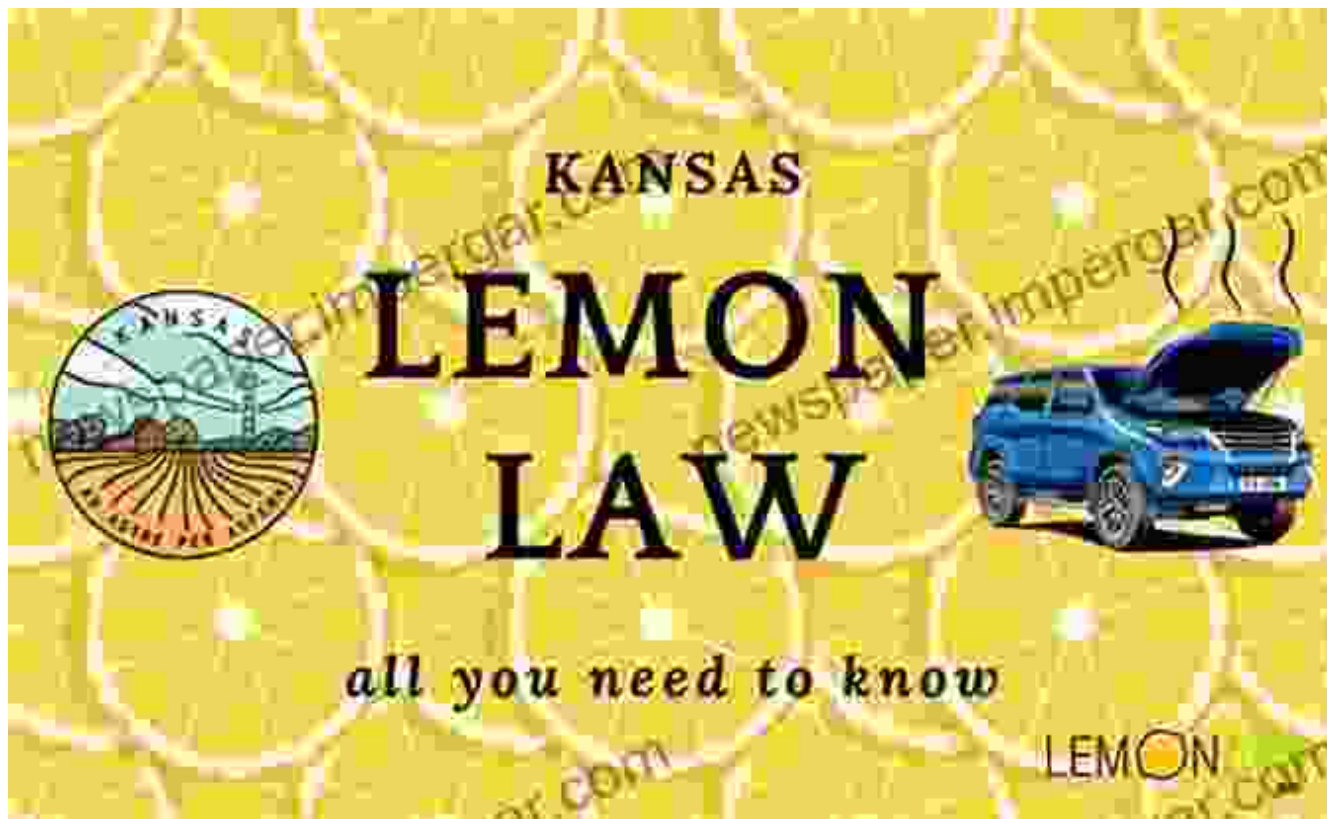
- You have a clear and concise description of the defect.

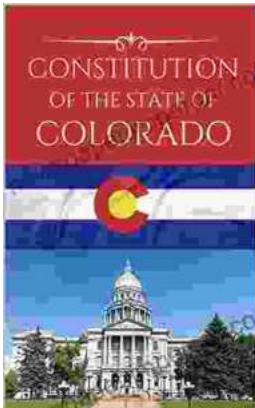
